



## Board of Governance Committee Membership

At St Mary's CE Primary School, the Board has established a number of sub-committees that it has delegated some responsibilities. These committees then carry out the delegated responsibilities and activities and report back to the Full Governing Body meetings termly.

**Finance & Resources** – Responsible for overseeing all the finance, human resources and business management aspects of the school. Ensuring that there is a clear and robust challenge to all financial expenditure. This committee will review the planned budget each year on an annual basis and at every meeting will review both the management accounts and the financial/statutory accounts.

**Curriculum and Standards** – Responsible for reviewing the curriculum, standards, targets and academic performance of the school. To ensure that the school is on a continual improvement for educational standards and that our children achieve the highest possible results.

All Governors are members of the Curriculum and Standards Sub Committee. The Chair is Sian Crosby.

**Personnel, Pupil and Welfare** - Responsible for over-seeing the staffing structure in relation to the school development plan, curriculum requirements and financial resources available. To monitor and evaluate the staff development programme, exercise delegated powers in the appointment and management of staff and review related policies. Also, responsible for reviewing policies and their effectiveness in relation to social inclusion and SEND. To monitor safeguarding, child protection, behaviour, discipline and racial equality. To support the distinctive Christian ethos of St Mary's and to ensure all our children are happy, safe and achieve.
